## **VOLUNTARY CLARIFICATION ANNOUNCEMENT**

This announcement is made by DT Capital Limited (the “**Company**”) on a voluntary basis.

The board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of the Company has been made aware that there has been certain companies operating in a similar business name as the Company, namely (i) Beijing Dingli Tianheng Asset Management Limited\* (北京鼎立天恒資產管理有限公司) (“**Beijing Dingli Tianheng**”), a company established in Mainland China with limited liability, (ii) China Dingli Capital Holding Group Limited (中國鼎立資本控股集團有限公司) (“**China Dingli Capital**”), a private limited company incorporated in Hong Kong, and (iii) Dingli Tianheng Brand Asset Management Limited (鼎立天恒品牌資產管理有限公司) (“**Dingli Tianheng**”), a private limited company incorporated in Hong Kong that is wholly legally and beneficially owned by China Dingli Capital.

Accordingly, the Company wishes to clarify that:

- (i) the Company has no relationship, connection nor affiliation with any organizations named “鼎立天恒 (Dingli Tianheng)”, “中國鼎立資本 (China Dingli Capital)”, “北京鼎立天恒 (Beijing Dingli Tianheng)”;
- (ii) the Company has never engaged nor cooperated with any organizations named “鼎立天恒 (Dingli Tianheng)”, “中國鼎立資本 (China Dingli Capital)”, “北京鼎立天恒 (Beijing Dingli Tianheng)” in the Hong Kong and Mainland China;
- (iii) the Company has no relationship nor affiliation with an individual named Yan Zongqi (閻宗琪), who currently holds 50% of the shareholdings in China Dingli Capital; and
- (iv) the Company has no relationship nor affiliation with an individual named Yan Tingxu (閻亭予), who is purportedly affiliated with Dingli Tianheng.

The Company reserves its right to take legal actions against relevant persons for publication or dissemination of inaccurate information and pursue other available legal remedies, including but not limited to passing off as it may think fit to safeguard the interests of the Company and its shareholders.

The Company would like to remind all shareholders and potential investors of the Company to exercise caution and not to place any reliance on any unauthorised and unofficial websites, social media platforms or unconfirmed sources of information. Any information concerning the Company should only be based on the Company's official announcements.
